§ 1. Subject of the contract

1. The Contractor agrees to perform the service of acoustic insulation of the wall in the Client's premises using the system chosen by the Client.
2. The service includes the installation of one of the acoustic insulation systems offered by the Contractor and the finishing of the wall according to the Client's choice.

§ 2. Completion Date

1. The parties agree that the commencement of the service will take place no later than start date
2. The Contractor agrees to complete the work by completion date

§ 3. Remuneration

1. For the performance of the subject of the contract, the Client agrees to pay the Contractor remuneration in the amount of amount PLN.
2. Payment will be made as follows:
 - a. Advance payment in the amount of advance payment amount PLN, payable by advance payment date
 - b. The remaining amount in the sum of amount PLN, payable upon completion of work, no later than payment date

§ 4. Obligations of the Parties

1. **The Contractor** undertakes to:

- a. Perform the service in accordance with applicable standards and regulations.
- b. Providing all necessary materials and tools.
- c. Adherence to deadlines for completion.
- d. Maintaining order at the place of service.

2. **The Client** undertakes to:

- a. Provide access to the place where the service is provided.
- b. Make payments in accordance with the terms of the agreement.
- c. Cooperate with the Contractor to the extent necessary for the proper performance of the service.

§ 5. Warranty and Complaints

1. The Contractor provides a warranty for the service performed for a period warranty period
from the date of service acceptance.

2. If defects are found in the service provided, the Client has the right to file a complaint within

§ 6. Acceptance of the Service

1. After completion of the work, the parties will prepare an acceptance protocol, which will constitute confirmation of completion of the service according to the agreement
2. Signing the acceptance protocol by the Client will signify no reservations regarding the performed service.

§ 7. Final Provisions

1. All changes and additions to this agreement require written form under penalty of invalidity.
2. Matters not regulated by this agreement shall be governed by the provisions of the Civil Code.

The client declares that he has read the technical data sheet of the product and the acoustic test certificate of the installed sound insulation system provided by the contractor before starting the work and is aware that the effectiveness of the insulation may be limited by factors such as lateral transmission of sounds through adjacent structural elements, leakages, installation penetrations, quality and condition of existing building materials, sound interference resulting from mechanical devices, sound transmission through windows, doors and other building openings, as well as incorrect installation or use of structural elements. The client accepts that it may not be possible to completely eliminate the penetration of sounds, and some of the sounds from behind the wall may remain audible and undertakes not to raise any claims or demands against the Contractor if the service has been performed in accordance with the contract and technical specifications.
